

**SAINT ALBERT CATHOLIC HIGH SCHOOL PARTICIPATION AGREEMENT  
AND RELEASE**

I understand and agree that during the novel coronavirus pandemic (COVID-19), to participate in summer sports I must agree to the following terms and conditions.

**Acceptance of Risk, Release and Indemnification**

The novel coronavirus, COVID-19, is a highly infectious, life-threatening disease declared by the World Health Organization to be a global pandemic. There is no current vaccine for COVID-19. COVID-19's highly contagious nature means that contact with others, or contact with surfaces that have been exposed to the virus can lead to infection. Additionally, individuals who may have been infected with COVID-19 may be asymptomatic for a period of time, or may never become symptomatic at all. Because of its highly contagious and sometimes "hidden" nature, it is currently very difficult to control the spread of COVID-19 or to determine whether, where, or how a specific individual may have been exposed to the disease. I am fully aware that there are a number of risks associated with participating in summer sports during the COVID-19 pandemic including without limitation: I could contract COVID-19 which could result in a serious medical condition or even death.

In consideration for being granted the opportunity to participate in summer sports during the COVID-19 pandemic, I, for myself, my heirs, assigns, and next of kin do hereby release and forever discharge, indemnify, and hold harmless St. Albert Catholic High School, its board, employees, agents, and students (collectively, the "released parties") from any liability for losses, damages, injuries or costs, including, without limitation, those described in this document, that may arise out of or that may in any way be related to such participation, whether caused by the negligence of the released parties or otherwise.

By signing this agreement, I acknowledge the contagious nature of COVID-19, the fact that it can be difficult to identify in another, and the inherent risk of exposure during participation to those who may be infected with COVID-19. I voluntarily assume the risk that I may be exposed to or infected by COVID-19 by participating and that such exposure or infection may result in personal injury, illness, permanent disability, and/or even death. In submitting this release, I acknowledge and represent that I have reviewed it and understand what it means and that I have signed this release with full consent. This release shall be binding upon my heirs, executors, administrators, and assigns.

**Agreement to Terms and Conditions**

I agree that I am personally responsible for my safety and actions while participating in summer sports during the COVID-19 pandemic. I agree to comply with all policies and rules, including but not limited to all St. Albert Catholic High School guidelines, signage and instructions. I acknowledge and agree that if I fail to follow policies and rules I will be subject to discipline as determined by St. Albert Catholic High School. I expressly acknowledge and agree that, while St. Albert Catholic High School will do its best to reduce the chance of transmission of COVID-19, St. Albert Catholic High School has not assumed or undertaken any obligation to guarantee my health.

I understand this authorization is voluntary. That is, I can refuse to agree to the terms of this agreement but if I do refuse to agree to such terms I will not be allowed to participate in summer sports.
